The **ROXBURY COMMUNITY COLLEGE**, the Awarding Authority, invites sealed bids from Contractors for the RCC Fume Hoods Replacement - 4th Floor at in Roxbury Crossing, Massachusetts, in accordance with the documents prepared by **FITZMEYER & TOCCI ASSOCIATES, INC.** .

The Project consists of but not limited to:

The Work includes providing all labor, materials, machinery, tools, equipment and other means of construction necessary and incidental to the completion the work shown on the plans and described in these specifications including, but not necessarily limited to demolition of existing hoods and installation of 4 new hoods, replacement of aged HVAC and Electrical components. This work will take place across 4 different classrooms and is intended to be completed simultaneously. * Note: The Awarding Authority has previously procured ALL Labconco fume hoods, work surfaces, cabinets, and enclosures which are stored off site. The General Contractor will be required to transport fume hood equipment from warehouse to project site as needed (there is no storage on campus). The fume hoods are presently stored approximately 10 miles away from campus.

The work is estimated to cost **\$425,000.00**.

Bids are subject to M.G.L. c.149 §44A-J & to minimum wage rates as required by M.G.L. c.149 §§26 to 27H inclusive.

General Bids will be received until **30 November 2023** on **12:00PM EST** and publicly opened online, forthwith.

Filed Sub-bids for the trades listed below will be received until **16 November 2023** on **12:00PM EST** and publicly opened online, forthwith.

Filed sub-bidders must be DCAMM certified for the trades listed below and bidders must include a current DCAMM Sub-Bidder Certificate of Eligibility and a signed DCAMM Sub-Bidder's Update Statement.
